

Note to parents and teachers of Belize

THE REASON WHY CHILDREN SHOULD NOT CONTINUE TO ATTEND CLASSES UNTIL THE POLICY IS RETRACTED & CHANGES ARE MADE TO THE NEW PENAL CODE LAWS!

TAKE YOUR CHILDREN OUT OF SCHOOL NOW –STOP THE HOMOSEXUAL AGENDA IN SCHOOLS AND THE COUNTRY, STOP THE CONFUSION OF YOUR CHILDREN IN THE AREA OF THEIR SEXUAL IDENTITY (Since the school is to promote that they can choose to be a boy or girl, depending on what they feel - no matter how they were born), AND YOU WILL KEEP YOUR CONTROL OVER THE SEXUAL LIFE OF YOUR CHILDREN WHO ARE MINORS (since the new CHANGES to the Criminal Code removes it from you).

Whereas the Alliance of Leaders and Ministers of Belize - (BelizeCan Patriots); have made many sacrificial and meaningful attempts to dissuade the Government from continuing down its path to destruction by having:

- Phase I – Over 8,650 residents of Belize march against the Gender Policy
- Phase II – Thousands pray, fast, occupy, and/or participate in vigils during our 21 Day occupation of Independence Plaza at the National Assembly
- Phase III – Thousands sign and continue to sign petitions Nationwide, demanding our Four(4) points of contention
- Phase IV – Contact Ministers of Government, requesting adherence to our Four(4) points
- Phase V – Awareness Campaign of the Corrupting of Our Education System thru Gender Policy...
- Phase VI - Awareness Campaign Of The Corrupting Of The Education System Thru The Gender Policy and the New AMENDMENT to the Penal Code (Cap.101 of the Laws of Belize).

Instead of giving in, the GOVERNMENT OF BELIZE – is now:

- **Attempting to implement LAWS to REMOVE YOUR RIGHTS OVER YOUR CHILDREN in the area of sex,**
- **PREPARING Teachers, Administrators and Counselors of Schools to get In YOUR HOME when YOU do not support their Homosexual Agenda and unlawful SEX;**
- **Offering ATTORNEYS and creating a LEGAL mechanism so that Homosexuals can sue us – be it at the School or in the society**

WE THEREFORE, keep our DEMAND THAT IN ACCORDANCE WITH THE PREAMBLE OF THE CONSTITUTION OF BELIZE, THE FOLLOWING STEPS BE TAKEN IMMEDIATELY BY THE GOVERNMENT:

- 1) Retraction (or Freezing) of the 2013 Revised Gender Policy;

- 3) ***An end to VICTIMIZATION in Belize by Government & Private Sector***
- 4) The Guarding of the Preamble of the Constitution – as is! (Unless changed by a National Referendum)
- 5) ***NEW: * Changes to the Amendment of Chapter 101 of the Laws of Belize (Criminal Code) to keep intact - Section "53" of the Current Criminal Code – and to Completely Delete Section 47G (3) - Which removes the Rights from Parents over their children less than 16 years old.***
